The policy:

This privacy policy notice with effect from 24/05/2018, version 1, is for this website; <http://www.greatplumsteadbowlsclub.co.uk/> the website of; Great Plumstead Bowls Club, Church Road, Great Plumstead, Norwich, Norfolk NR13 5AB and governs the privacy of those who use it. We may change this policy from time to time so you may want to check that you are happy with any changes. The purpose of this policy is to explain to you how we control, process, handle and protect your personal information while browsing or using this website, including your rights under current laws and regulations. Website, internet cookies and web page links:
